- 16 Mar 1880** **George Hemingway** **Sheffield**
Administration of the Personal Estate of George Hemingway late of Sheffield in the County of York who died 16 March 1880 at Sheffield was granted at Wakefield to James Bamforth of 54 Mottram Road, Hyde in the County of Chester, Engineer the Brother by the Half Blood and one of the Next of Kin [margin note indicates resworn September 1880 £800 - no reference to this in the calendar]
- 12 Apr 1880** **Ann Maria Hemingway** **Batley**
Administration of the Personal Estate of Ann Maria Hemingway late of Batley in the County of York Widow who died 12 April 1880 at Batley was granted at Wakefield to William Hemingway of Taylor Street Batley Spinner the Son and one of the Next of Kin
- 03 Oct 1880** **Mary Hemingway** **Liverpool / Wolverhampton**
Administration of the Personal Effects of Mary Hemingway (wife of John Hemingway) late of 47 Ullswater Street, Breck Road in the City of Liverpool who died 3 October 1880 at Wolverhampton in the County of Stafford was granted at Liverpool to the said John Hemingway of 47 Ullswater Street, Compositor
- 24 Jan 1881** **Joseph Hemingway** **London**
The Will of Joseph Hemingway late of Chase Cottage near Potters Bar in the Parish of South Mimms in the County of Middlesex, Coal Merchant who died 24 January 1881 at Chase Cottage was proved at the Principal Registry by Thomas Samuels of Linden House, Hadley in the said County, Gentleman and William Billing of the Highstone, Hadley, Coal Merchant the Executors
- 28 Jan 1881** **John Hemingway** **East Cottingwith**
The Will of John Hemingway late of East Cottingwith in the County of York, Joiner who died 28 January 1881 at East Cottingwith was proved at York by William Hemingway of 8 Priory Street in the City of York, Joiner the Brother the sole Executor
- 03 Jul 1881** **Mary Jane Hemingway** **London**
The Will of Mary Jane Hemingway late of the "Bank of Friendship" Public House, Harford Street, Mile End Road in the County of Middlesex, Widow who died 3 July 1881 at the "Bank of Friendship" was proved at the Principal Registry by Fanny Chown (Wife of Henry Chown) and Kate Hemingway Spinster the Daughter both of the "Bank of Friendship" the Executrixes
- 03 Nov 1881** **Frances Hemingway** **Earlsheaton**
Administration of the Personal Estate of Frances Hemingway late of Earlsheaton, Dewsbury in the County of York Widow who died 3 November 1881 at Earlsheaton was granted at Wakefield to George Hemingway of Earlsheaton, Blanket Raiser the Son and one of the Next of Kin
- 06 Apr 1882** **Maria Hemingway** **Preston**
The Will of Maria Hemingway late of Preston in the County of Lancaster, Widow who died 6 April 1882 at Preston, was proved at Lancaster by Richard Cooper of 100 Fishergate Hill, Preston, Coal Agent and James Henry Longworth of Chapel Street, Preston, Estate Agent the Executors
- 05 Jul 1882** **Elizabeth Hemingway** **Horsforth**
The Will of Elizabeth Hemingway late of Horsforth in the County of York Spinster who died 5 July 1882 at Horsforth was proved at Wakefield by Sarah Ann Gill of Lambert Terrace, Woodside, Horsforth, Spinster and Hannah Maria Wilkinson (Wife of William Wilkinson) of Butcher Hill, Headingley in the Borough of Leeds in the said County the Nieces the Executrixes

- 01 Oct 1883** **James Hemingway** **Blackpool**
The Will of James Hemingway late of Lytham Road, South Shore, Blackpool in the County of Lancaster, Gentleman who died 1 October 1883 at Blackpool was proved at Lancaster by Sarah Anne Porter (Wife of John Edward Porter) of the "Manchester" Hotel, Blackpool the Daughter and Richard Lund of Blackpool, Collector to the Fylde Waterworks Company the Executors
- 08 Oct 1883** **Thomas Middlebrook Hemingway** **Birstall**
Administration of the Personal Estate of Thomas Middlebrook Hemingway late of Coach Lane, Birstall in the County of York, Dyer who died 8 October 1883 at Howley, Batley in the said County was granted at Wakefield to Elizabeth Hemingway of White Lea, Batley Widow the Relict
- 17 Feb 1884** **George Hemingway** **Blacktoft, ERY**
Administration of the Personal Estate of George Hemingway late of Blacktoft in the East Riding of the County of York, Joiner and Wheelwright who died 17 February 1884 at Blacktoft was granted at York to Maria Hemingway of Blacktoft, widow the Relict
- 01 Mar 1884** **Charlotte Hemingway** **London**
The Will of Charlotte Hemingway formerly of 45 Clifton Hill, St Johns Wood but late of Denmark House, 39 Loudoun Road, St Johns Wood in the County of Middlesex Widow who died 1 March 1884 at Denmark House was proved at the Principal Registry by William Hemingway of Denmark House, Commission Agent the Son the sole Executor
- 08 Mar 1884** **John Hemingway** **Hemsworth**
The Will of John Hemingway late of Hemsworth in the County of York, Gentleman who died 8 March 1884 at Hemsworth was proved at Wakefield by Charles Waller of Thorne in the said County Gentleman and Claude Leatham of Hemsworth, Solicitors the Executors
- 29 Jul 1884** **John Hemingway** **Dewsbury**
The Will of John Hemingway late of Ashworth Road, Dewsbury in the County of York, Bookkeeper who died 29 July 1884 at Ashworth Road, Dewsbury was proved at Wakefield by Hannah Hemingway of 20 Hemingway's Yard, Ashworth Road, Widow the Relict and Daniel Hemingway of 39 Tewkesbury in the County of Gloucester, Professor of Music the Sons the Executors
- 16 Sep 1884** **Isaac Hemingway** **South Ossett**
The Will of Isaac Hemingway late of South Ossett in the Parish of Dewsbury in the County of York Cloth Weaver who died 16 September 1884 at South Ossett was proved at Wakefield by William Hemingway of Intake Lane, South Ossett, Rag Merchant and James Hemingway of Park Square, South Ossett, Stone Mason, the Sons, two of the Executors
- 20 Sep 1884** **William Hemingway** **Hull**
The Will of William Hemingway late of the Borough of Kingston upon Hull, Tailor who died 20 September 1884 at Kingston upon Hull was proved at York by Hannah Hemingway of 12 Walmsley Street, Kingston upon Hull, Widow the Relict and William Hemingway of 42 Mytongate, Kingston upon Hull, Tailor and George Henry Hemingway of 77 Trinity Street, Kingston upon Hull, Merchants Clerk, the Sons the Executors
- 24 Feb 1885** **Robert Thomas Gates Heminway** **Holborn / Clerkenwell London**
The Will of Robert Thomas Gates Heminway formerly of 9 Greville Street, Brooke Street, Holborn but late of 26 Myddleton Street, Clerkenwell both in the County of Middlesex who died 24 February 1885 at 26 Myddleton Street was proved at the Principal Registry by Caroline Heminway of 26 Myddleton Street, Spinster the Daughter the sole Executrix
- 28 Mar 1885** **Elizabeth Hemingway** **Melcombe Regis, Dorset**
The Will of Elizabeth Hemingway formerly of Weymouth and of Melcombe Regis in the County of Dorset, Licensed Victualler but late of Westham Wyke Regis in the said County, Widow who died 28 March 1885 at Westham Wyke Regis was proved at Blandford by William Thomas Hemingway of Westham Wyke Regis, Draper, the Son the sole Executor
- 23 Apr 1885** **Reuben Joseph Hemingway** **Bootham Asylum, York**
Administration of the Personal Estate of Reuben Joseph Hemingway late of Bootham Asylum, York in the County of York, Esquire, a Bachelor who died 23 April 1885 at Bootham Asylum was granted at the Principal Registry to Mary Whitehead (wife of John Blakey Whitehead Esquire) of Ashday Lea, Rawtenstall in the County of Lancaster, the Sister and one of the Next of Kin
- 29 May 1885** **George Hemingway** **Lightcliffe**
The Will with a Codicil of George Hemingway late of Lightcliffe in the Parish of Halifax in the county of York, Maltster who died 29 May 1885 at Lightcliffe, was proved at Wakefield by Mary Hemingway of Lightcliffe, Widow, the Relict and Charles Hemingway of Manchester in the County of Lancaster and John William Hemingway of Leeds in the County of York, Maltsters, the Brothers the Executors
- 05 Jun 1885** **Ellen Hemingway** **Bath**
The Will of Ellen Hemingway late of 20 Walcot Parade in the City of Bath, Spinster who died 5 June 1885 at 20 Walcot Parade was proved at Bristol by Jes Moody of 5 Sydney Buildings in the City of Bath, Accountant and John Killick of the Poplars, Sussex Place, Ashley Road in the City and County of Bristol, Stationer the Executors

- 10 Aug 1885** **James Hemingway** **Dewsbury**
Administration of the Personal Estate of James Hemingway late of New Street, West Town, Dewsbury in the County of York, Carpet Weaver, who died 10 August 1885 at New Street was granted at Wakefield to Elizabeth Hemingway of New Street, Widow the Relict
- 01 May 1886** **William Hemingway** **Hull**
The Will of William Hemingway late of 8 Drypool Square in the Borough of Kingston upon Hull, Broker, who died 1 May 1886 at Kingston upon Hull was proved at York by William Kitching of 53 Strawberry Street, Kingston upon Hull and Joseph Sidebottom of 13 Spyvee Terrace, Spyvee Street, Kingston upon Hull, Keelmen the Executors
- 17 Jun 1886** **Louisa Hemingway** **Harrogate**
The Will with a Codicil of Louisa Hemingway late of Granby House, High Harrogate in the County of York, Spinster who died 17 June 1886 at Granby House was proved at Wakefield by Thomas Butler of Staincliffe Road, Dewsbury Moor in the Parish of Dewsbury in the said County Solicitor's Clerk and Frances Mary Linfoot of Granby House, Spinster, the Niece the Executors
- 28 Oct 1886** **Rachel Hemingway** **Elland, Huddersfield**
Administration of the Personal Estate of Rachel Hemingway (wife of Stephen Hemingway) late of Whitwell House, Elland near Huddersfield in the County of York who died 28 October 1886 at Whitwell House was granted at Wakefield to the said Stephen Hemingway of Whitwell House, Woollen Manufacturer
- 11 Nov 1886** **Robert Hemingway** **Earlsheaton**
The Will of Robert Hemingway late of Bank Top, Earlsheaton in the Parish of Dewsbury in the County of York, Blanket Weaver who died 11 November 1886 at Bank Top was proved at Wakefield by Charlotte Hemingway, Widow the Relict, Jane Firth Hemingway, Spinster the Daughter, and George Hemingway, Hand Loom Weaver the Son all of Bank Top the Executors
- 04 Dec 1886** **Henry Hemingway** **Liversedge**
The Will of Henry Hemingway late of Norristhorpe, Liversedge in the County of York who died 4 December 1886 at Norristhorpe was proved at Wakefield by Joseph Denton of 10 Wilson Wood, Batley Carr near Dewsbury in the said County, Woollen Cloth Manufacturer and William Henry Askham of 11 Kupferstrasse, Aachen in Germany, Woollen Manufacturers Manager, the Executors
- 13 Mar 1887** **Ann Hemingway** **Barnsley**
Administration of the Personal Estate of Ann Hemingway (wife of John Hemingway) late of Pitt Street, Barnsley in the County of York who died 13 March 1887 at Pitt Street was granted at Wakefield to the said John Hemingway of Pitt Street, Colliery Labourer
- 02 Apr 1887** **Edward Hemingway** **Golcar**
Administration of the Personal Estate of Edward Hemingway late of Ley Moor, Golcar in the County of York who died 2 April 1887 at Ley Moor was granted at Wakefield to Rachel Hemingway of Ley Moor the Relict (See Rachel Hemingway 1889)
- 18 Aug 1887** **Sarah Hemingway** **Batley**
The Will of Sarah Hemingway otherwise Berry formerly of Huddersfield but late of Howdenclough, Batley both in the County of York Spinster who died 18 August 1887 at Howdenclough was proved at Wakefield by Margaret Hall (Wife of Thomas Hall) of Howdenclough, the Niece the sole Executrix
- 03 Nov 1887** **Joseph Hemingway** **Wakefield**
Administration of the Personal Estate of Joseph Hemingway late of Stanley Lane End near Wakefield in the County of York, Pit Labourer, a Bachelor who died 3 November 1887 at Stanley Lane End was granted at Wakefield to George Hemingway of Stanley Lane End, Cowkeeper and Dairyman, the Brother and one of the Next of Kin
- 04 Dec 1887** **George Hemingway** **Knottingley**
The Will of George Hemingway late of Knottingley in the County of York who died 4 December 1887 at Knottingley was proved at Wakefield by Robert Hayton Thorp of Moorfield near Goole in the said County, Farmer, the surviving Executor
- 26 Apr 1888** **Emanuel Hemingway** **Liversedge**
The Will of Emanuel Hemingway late of the 'New Yew Tree' Inn Liversedge in the Parish of Birstall in the County of York, Innkeeper, who died 26 April 1888 at the said Inn was proved at Wakefield by Sarah Hemingway of the said Inn, Widow, the Relict one of the Executors
- 27 Apr 1888** **Benjamin Hemingway** **Earlsheaton**
Administration of the Personal Estate of Benjamin Hemingway late of Earlsheaton near Dewsbury in the County of York, Beamer who died 27 April 1888 at Earlsheaton was granted at Wakefield to Mary Hemingway of Providence Street, Earlsheaton, Widow the Relict

- 04 Jun 1888 Elizabeth Hemingway Richmond, Surrey**
Administration of the Personal Estate of Elizabeth Hemingway late of 9 Lichfield Gardens, Richmond in the County of Surrey, Widow, who died 4 June 1888 at 9 Lichfield Gardens, was granted at the Principal Registry to John Hemingway of 9 Lichfield Gardens, Medical Student, the Son and one of the Next of Kin [Note added resworn Dec 1888 at £2,205]
- 02 Jan 1889 Rachel Hemingway Golcar, Huddersfield**
The Will of Rachel Hemingway late of Leymoor, Golcar near Huddersfield in the County of York, Widow who died 2 January 1889 at Leymoor was proved at the Principal Registry by Joseph Edward Hemingway of 36 King Street, Huddersfield, Saddler, the Son the sole Executor. (See Edward Hemingway 1887)
- 26 Feb 1889 William Hemingway York**
The Will of William Hemingway late of 8 Priory Street in the City of York, Joiner, who died 26 February 1889 at 8 Priory Street was proved at York by Elizabeth Hemingway of 8 Priory Street, Widow the Relict the sole Executor
- 01 May 1889 David Hemingway Calverley Moor**
The Will of David Hemingway formerly of Calverley Moor, Calverley in the County of York, Farmer, but late Thornhill Street, Calverley Gentleman who died 1 May 1889 at Thornhill Street was proved at Wakefield by Sarah Hemingway of Thornhill Street, Widow, the Relict, James Hemingway of Filbert Street, Otley Road, Bradford, in the said County, Milkman, the Son, John Gaunt of Leeds Road, Calverley Moor, Farmer and James Jeffrey of Thornhill Street, Weaver, the Executors
- 07 Aug 1889 James Hemingway Hightown, Liversedge**
The Will of James Hemingway late of Hightown in the Township of Liversedge in the Parish of Birstall in the County of York, Contractor, who died 7 August 1889 at Hightown was proved at Wakefield by Alfred Carver Hemingway of Lynn in the State of Massachusetts in the United States of America but at Quaker Lane, Hightown, Machine Maker, the son one of the surviving Executors. [Margin note records Proved again June 1903]
- 07 Aug 1889 James Hemingway Birstall**
HEMINGWAY James of Hightown Liversedge Birstall Yorkshire contractor died 7 August 1889 Probate Wakefield 12 June to John Hemingway machine-maker Effects £220 9s. Former grant November 1889.
- 10 Aug 1889 John Hemingway Horbury & Dewsbury**
The Will of John Hemingway formerly of Horbury Hall, Horbury and of Dewsbury both in the County of York, Woollen Yarn Spinner but late of High View House, Harrogate in the said County Gentleman who died 10 August 1889 at Harrogate was proved at Wakefield by Thomas Greenwood of Hall Lane in Armley near Leeds in the said County Gentleman one of the Executors. [Margin note indicates resworn Aug 1894 £7,697]
- 07 Nov 1889 Abraham Hemingway Brighouse**
Administration (with the Will) of the personal Estate of Abraham Hemingway late of Brighouse in the County of York, Maltster and Carrier, who died 7 November 1889 at Brighouse was granted at Wakefield to Mary Elizabeth Freeman (Wife of Thomas Freeman) of Brighouse, the Daughter the Residuary Legatee for Life substituted as to a Moiety.
