The Will of John Hemingway late of Southowram in the Parish of Halifax in the County of York, Stone Merchant, deceased, who died 2 March 1857 at Southowram aforesaid was proved at Wakefield by the oaths of John Hemingway of Southowram aforesaid Stone Merchant and Edward Hemingway of Halifax aforesaid Linen Draper, the Sons and the Executors
- 16 Aug 1857** **Sarah Hemingway** **Tankersley**
Letters of Administration of the Personal Estate of Sarah Hemingway (Wife of Henry Hemingway) late of Tankersley in the County of York deceased, who died 16 August 1857 at Tankersley aforesaid, were granted at Wakefield to the said Henry Hemingway of Tankersley aforesaid Farmer he having been first sworn
- 21 Mar 1859** **John Hemingway** **Rooks, Hipperholme**

Former Grants at Wakefield May 1859 and November 1887
